Introduction

The year from April 2022 to March 2023 has been a year of growth and development for the CHA.

We have welcomed new members, concluded pieces of work, progressed others building relationships and networks along the way.

This report seeks to give a summary of the work covered within those 12 months.

Impact of the Pandemic

The pandemic has continued to have an impact on the Association and the Community Hospitals it works with, although this impact has lessened over the 12 month period.

Committee Meetings have continued monthly. These continue virtually, as this enables them to happen monthly rather than quarterly which we have found beneficial in terms of progressing workstreams and being responsive to members requests.

Virtual meetings help us reduce our cost base increasing our sustainability both financially and in terms of our carbon footprint. The hybrid model of working will continue for the next year.

There was one face to face meeting which took place at Cirencester Community Hospital. It was great for the Committee to meet face to face and to hear about all the magnificent work being undertaken in Community Hospitals in Gloucestershire.



The Committee has continued to ensure discussions include all four nations.

QExchange Project: Community Hospitals: Embedding Covid-19 positive impact changes through shared learning

This project formally concluded but work to share the learning continues via the Special Interest Group. A face to face team reflection ensured learning was maximised and allowed us to celebrate the publication of the project report.



Special Interest Group (SIG)

The Community Hospitals Special Interest Group hosted by the Q Community has held 5 virtual forums this year. Some have been presentations from the Award Winners of the 2022 Innovation and Best Practice Awards which were generated from the QExchange Project. Membership of the Special Interest Group has grown over the 12 months, and at the end of March was 53 members.

Two resource packs have been developed and shared based on learning from the QExchange Project. They are:

Integrated Care

The SIG changed its name to make it more explicit that the focus was on sharing good practice and is now called "Community Hospitals SIG: sharing good practice."

The SIG project has enhanced the CHA relationship with Q who are supporting us to share further learning from the QExchange project in 2023/2024.

The final report will be submitted to Q in April 2023 by the project lead.

Growth of membership

There has been an increase of twenty one personal memberships over the 12 month period.

Organisational membership has remained static over this period.

People

Dr Andrew Wheeler and Trish Jay have stood down from the committee and there have been no new members.

Social Media

The CHA has been active on social media with the greatest engagement happening on Twitter. Social media has proven a crucial tool in connecting with Community Hospital colleagues and developing connections for the organisation.

- Twitter followers grew by 200, a significant increase on 40 the previous year
- Facebook followers increased by 10
- LinkedIn followers increased by 59

Support for Community Hospitals

During 2022/23 we connected Community Hospital members looking to collaborate on pieces of work and share best practice.

The CHA supported campaigns relating to Community Hospitals including Insch and Ellen Badger.

Support was provided to an academic team at the University of Bocconi advising the Italian Government on their community hospital strategy. The CHA president Helen Tucker spoke at two of their national conferences.

We produced 6 CHA newsletters which were shared with hundreds of Community Hospital supporters.

A monthly newsletter was commenced on LinkedIn. 3 editions have been published and it already has 76 subscribers.

Providing a Voice for Community Hospitals

Several Blogs were posted written by Community Hospital staff and CHA committee members past and present – sharing their experiences, innovations and learning.

Questions raised by Community Hospital colleagues were shared on social media which allowed connections to be developed between individuals, teams and organisations.

The Community Healthcare Services Department at the Department of Health and Social Care (DHSC) contacted the CHA about the scope of community hospitals, and a meeting was held between Helen Tucker and three of the team. A follow up has been requested by the DHSC Community Health Services Policy, Recovery and COVID lead, to open the discussion to the wider team, and this is being arranged.

The Community Hospitals Special Interest Group within the Q Community has been exploring an opportunity to become a member within Hexitime, a timebank for health professionals. This would be funded through Q. Members of the SIG project team have had initial meetings with John Lodge from Hexitime and have joined as individuals.

Evelyn Prodger, CHA Chair, was part of the panel for the Gold Standard Framework for wards (including Community Hospitals).

Website development

Work has continued to develop our refreshed website. We continue to listen to feedback and make it more user friendly.

Additional pages have been developed for the Special Interest Group.
