#### > The Future of Royston Hospital

The health secretary Matt Hancock gave encouragement to campaigners for Royston hospital, whose hospital lost it s beds 6 years ago. Matt Hancock stated that "Royston is an example of how the NHS needs to be formulated in the future", and that it is about "making sure we support the NHS where people live." Sarah Hillman - a director of community interest company Royston Community Health, which has been campaigning for the site to be turned into hub for health and social care - said: "Last month we sent an open letter to both our local MPs, as we have been urging the NHS for 6+ years to use Royston Hospital as a health and social care hub. RCH thanks Sir Oliver for his question in Parliament and welcomes the positive response that he received about such hubs. "It is evidence that what we propose fits well with the long-term plan for the NHS, and that the secretary of state supports moving healthcare out of hospitals and into the community because of the health benefits, efficiencies and reduced costs. In a cash-strapped NHS area, that makes a lot of sense."



# **Launch of Report on Efficiency of Community Hospital Wards**

The long-awaited report on the efficiency of community hospital wards has now been published. This report on the Mocha (Models of community hospitals) was carried out by the University of Leeds, and was led by Professor John Young. It was funded by the NIHR. It sheds light on the efficiency and cost of community hospital inpatient services, and also offers a tool for providers to assess their optimum efficiency. The study found that the efficiency of community hospital wards is comparable with acute hospitals and that modifiable performance factors might lead to potential efficiency savings. This is an important piece of work, and adds to the evidence base on the performance and contribution of community hospitals.
